How are the portfolio assets invested at the moment	The majority of the portfolio assets were liquidated in late January 2006. Almost all of the assets are now invested in 3 month Treasury Bills or similar types of investments.		
How much will I get back	It is too early to know.		
What are you working on at the moment	We took possession of over 200 boxes of @rgentum records. We are reviewing those records in an attempt to see whether we have all the information we need and, if not, to identify what we are missing. We are also attempting to get information from third parties, eg @rgentum's auditors, to assist us in efficiently winding up the Funds. We then plan to update @rgentum's accounting records to, among other things, establish accurate Fund values, ascertain if the assets located by us, by Fund, correctly reflect the assets "owned" by each Fund, and to see if any Fund assets might remain to be located.		
How long will this process take	Deficiencies in the @rgentum records that we have located to date are hampering our ability to carry out our duties under the Court Order as quickly as we would wish. We suspect it will be some time before we have completed our work.		
What happened to these Funds	We are looking into this question.		
Can I transfer or sell my units	No.		
Who pays the fees and expenses of the Receiver	The court order appointing us allows us to take them from the Funds. How much will be taken from each Fund will probably not be determined until the conclusion of the assignment.		
Is there a formal claims process	There is no formal claims process at this time. The Receiver will provide stakeholders with notice of the process at a later date.
